

## **2021-22 PRESIDENTIAL EXPENSES**

In accordance with RI Bylaws section 18.080, Rotary International is required to report all expenses that are reimbursed to, and all payments made to or on behalf of the president, president-elect, president-nominee. The majority of the expenses included in the presidential budgets are for travel expenses related to the duties of the offices of the president, president-elect and president-nominee.

During 2021-22, the president spent 25 days and the president-elect and president-nominee each spent 27 days attending board meetings, the International Assembly, the International Convention, the Council on Legislation or related meetings. They also participated in various additional committee and training events throughout the year.

In addition, the president attended events to promote Rotary International in approximately 39 countries, dedicating 203 days out of the year to such travel. The president-elect attended events in approximately 8 countries, with 95 days of such travel. Much of this travel was in response to invitations to attend events of Rotary clubs, districts, and zones.

Further to these travel commitments, the president, president-elect and president-nominee also spent time in Evanston, IL, USA to carry out the responsibilities of their offices including administrative matters, planning activities, and meetings.

Rotary International's financial statements for 2021-22 include total expenses of \$1,291,917 for the president, president-elect and president nominee.
